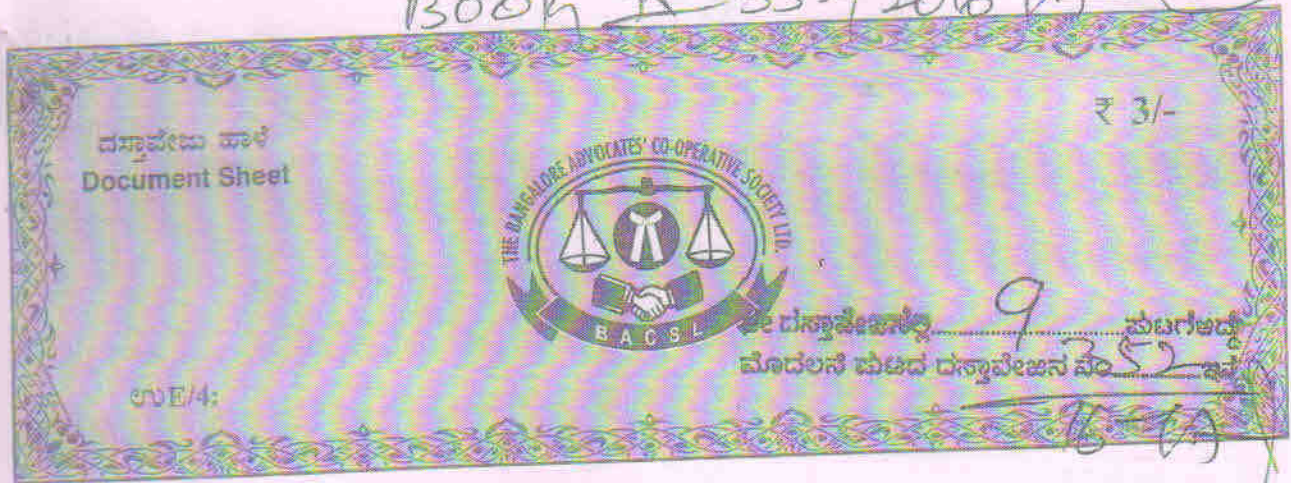

Patil has met with an fatal road accident and he expired in the said incident on 05-07-2015 On account of his death the trustees of the trust amicably and by consultation to each other and after comprehensive discussion with each other the trustees have decided to Amend the said trust for the above said reason. A meeting of the trustees was called and it has been unanimously decided to admit Smt. Jayashree & Smt. Swetha as trustees of the trust and all the trustees have authorized the general secretary to present the document and complete the registration of the same as per resolution of the trust Dt. 06-01-2017 and hence this deed of Amendment of trust hence, hereinafter the above said Amit who is no more Trustee of the Trust.






