CONDITIONS :

1. This registration is subject to rule 3 (5)(4).
2. The Governing council shall obey all the conditions and rules mentioned in rule 4 (4) .
3. The school building, measurement, building, education, equipments, Staff, and Economic facilities shall be provided as per rules.
4. The school shall be run in the medium for which granted to the school and school shall be run in the same place and not to change its place in any manner
5. Subject to the conditions of KEB 1983 framed under KEI (CRPC) rules 1995 and its sub rule 3,4,5 and grant in aid and the rules framed under sec. 36 of Karnataka Education Institutions (Primary and High schools) renewal of approval rules 1999.
6. As per registration this high school as per Govt. notification No. ED/175/PMC/95 dt; 7.9.1998 dt; 29.12.1998 this school is permanently unaided one and the board of management shall execute on stamp paper of rs.10/- and that, they will not claim any aid from the Govt. and it shall be notarized before the Notary.
7. The Karnataka private education societies (pvt. aided primary and high education societies employees appointment, service conditions and rules 1999 are to be followed.

- 8) The books & Examination system has to be adopted as prescribed by the Department.
- 9) Minimum 25% attendance is required in each class for which permission is granted.
- 10) Only the trained Teachers are to be appointed and as per the Rules of the Department under Schedule 8 of Kar.Edu.Act (36 & 39) all the Registered schools approval and temporary approval comes under preview of said Act.
- 11) Every year the Medical examination has to be conducted.
- 12) In order to start the school the Board of Management has to keep security deposit in the joint account of Dist.Dy.Director & Board of Management.
- 13) As per Karnataka Education Act and rules, all the basis facilities such as library, play ground, school building, and other facilities shall be provided within one year otherwise, this permission will be cancelled.
- 14) With regard to opening of School and admission of the student the information shall be provided, to the Department within one month from the date of starting of education year, in case the school is not opened, and any of the conditions of the found violated, this order stands for cancelled suo-moto.
- 15) A separate toilet and drinking water facility should be provided to the female students and male students.
- 16) For the preliminary approval the proposal has to be submitted to the Dy.Director, as per schedule -III of check list of Govt.order dtd:30/9/2007 after obtaining the same, on this basis within 3 months compulsorily the preliminary approval has to be issued,

- 17) With regard to protection of school building, such as against the Fire, electrocution, tempest, etc., it has to be ascertained in detail for the protection. Within the 100yards of the school area, it shall be mentioned, that, any kind sale of tobacco products are prohibited.
- 18) The board of Management if provides any false information, the Department has reserved powers to cancel the registration.
- 19) As per the Govt.Notification No.ED/369/PGC/2014 dt:11/11/2014 and the circular of this office dt:14/11/2014, it has to be ascertained regarding compliance of the conditions.
- 20) As per Govt.Notification ED/709/PGC /2017 dt:7/3/18 and the circular of this office dt:26/3/2018, it has to be ascertained whether the conditions are followed or not.
